

**EXPRESSION OF INTEREST FOR THE PROVISION OF FOOD TRUCKS AND
DRINKS STALLS DURING THE VALLETTA PAGEANT OF THE SEAS 2022
ACTIVITIES**

April 2022

1. INTRODUCTION

The 2022 edition of the Valletta Pageant of the Seas celebrates the 80th anniversary of the Santa Marija Convoy operation through boat races, music, projections, performances and fireworks.

The area of interest is Quarry Wharf and there are not enough food and drink outlets in the area to cater for the people expected.

The Valletta Cultural Agency is inviting prospective economic operators to submit an application to register their expressions of interest in providing bar stalls and food trucks services to the audience on the night as per the hereunder conditions.

Disclaimer:

Pre-COVID, audience numbers for the Valletta Pageant of the Seas events ranged between 20,000 and 25,000 in Valletta and more spread around the Harbour. The event will follow health regulations in force at the time. In case of restrictions on the number of attendees allowed, in accepting proposals for Food Trucks and Drinks, the Agency will respect a ratio of 1 food and 1 drinks stall per 1000 people attending.

Prospective applicants are to note that by submitting an application as specified below, they are confirming agreement to all of the terms and conditions related to the Expression of Interest for the Provision of Food Trucks and Drinks Stalls during the Valletta Pageant of the Seas 2022 Activities which shall be held on 25th June 2022.

Prospective applicants are to note that although applications may be submitted, evaluated and contracts signed, in case of new restrictions on the hosting of cultural events published by the Health Department and/or inclement weather, the Event might be postponed or cancelled. In such a circumstance, the application and awardee fees may be refunded. No other compensation claims shall be entertained by the Valletta Cultural Agency.

The application shall be declared null if any information provided is incorrect and/or not verified.

2. GUIDELINES

2.1 | INSTRUCTIONS TO PROSPECTIVE APPLICANTS

1. Prospective applicants are to submit a duly filled in and endorsed Application Form for the provision of food trucks and/or drink stalls.
2. Prospective applicants are to ensure that the contact name on the Application Form is that of the individual who, if successful, shall enter into an agreement with the Valletta Cultural Agency for the provision of food trucks and drink stalls during the Valletta Pageant of the Seas 2022 Activities.
3. Prospective applicants are encouraged to read the terms and conditions of this Expression of Interest.
4. By submitting an application, it is understood that the applicant has read and is in agreement with the terms and conditions of this Expression of Interest and affirms all Declarations. No conditions and alterations to the requirements listed in this document shall be introduced / imposed by the applicant on the Valletta Cultural Agency.
5. By submitting an application, applicants shall be confirming that their submissions shall remain valid for a period of 90 days from the submission deadline.

The **opening of applications** will take place on **Friday 15th May 2022 at 13:00 hours**. An opening schedule shall be affixed on the notice board of the Valletta Cultural Agency in the sequence of how applications are opened. Only the name of the applicant submitting an application in connection with the Expression of Interest for Food Trucks, and for Drink Stalls separately shall be displayed. Prices shall not be listed in the opening schedule.

Late or incomplete applications will not be considered.

2.3 SUBMISSION REQUIREMENTS

1. Each applicant may apply for one (1) to three (3) food and/or drink stalls.
2. The application is to include the following:
 - a. A duly filled in and signed application form and declaration (Annex 2)
 - b. List of products for sale (Beverage menu and Food menu)
 - c. Itemised pricelist
 - d. Photos / Sketch illustrating the food trucks / drink stalls
 - e. Checklist (Annex 3)

Should one or more of the listed requirements or fields be missing or incomplete, the submitted application shall be immediately disqualified and will not be considered further.

2.4 SELECTION AND EVALUATION

Each application will be treated in strict confidence by the selection board.

Spaces will be awarded on a first-come, first-served basis as long as the application fulfills all the requirements of this call.

Some applicants may be put on a reserve list and contacted at a later date.

The Contracting Authority reserves the right to select and/or reject any or all of the submitted applications. Should none of the applicants be considered satisfactory, it reserves the right to assign the designated stalls to other economic operators (not necessarily involved in this Expression of Interest).

3. TERMS AND CONDITIONS

3.1 PRODUCTS

1. The Agency is seeking offers from applicants who can match, with their offer, the feel and quality of the Valletta Pageant of the Seas, an artistic event based on the commemoration of a significant event in Maltese history.
2. Food trucks or stands must provide a menu with a brief description of each dish. The menu must preferably include at least one vegan/dairy free and gluten free option in their selection. Once agreed with the Agency, this list will be considered final.

3. Drink trucks or stands must provide a selection of alcoholic and/or non-alcoholic drinks. Once agreed with the Agency, this list will be considered final.
4. Trucks or stands may also provide both food and drinks.
5. Each truck/stand must clearly display a list of prices for each item on sale in a prominent area where the public can easily view. Prices are to be in compliance with local regulations.
6. The applicant must only sell items as agreed upon and abide by the instructions that may be given by the organizer both before and after the activity as well as comply with the Covid 19 regulations that will be up at the time.
7. The Applicant must ensure all staff on the day the service will be rendered will be wearing specific uniforms complementing the event. The uniforms consist of black pants and shirt for all staff attending the stall.
8. Ensure that the stall is visually set up to complement the event and is attractive and elegant. The Agency may add some props to the set-up to make it fit in better with the visual concept. The applicant is to provide photos/sketch illustrating the stall.
9. The applicant must comply with the Valletta Cultural Agency's Environmental Policy as listed below:
 - a. Packaging should be reduced at source. Don't use or promote products that have unnecessary packaging and reduce all packaging whenever possible. Packaging should be made of compostable materials.
 - b. Use compostable disposables. All food waste and paper disposables must be added to the compost bins.
 - c. The sale of drinking water in 50cl single-use plastic bottles is prohibited during the event. Water must be provided in refillable containers or compostable disposables. An exception can be made for the sale of 2L bottles accompanied by compostable disposable cups.
 - d. Applicants are encouraged to consider adopting a lower price for the refilling of reusable cups brought by the audience members but this is not mandatory.
 - e. Use only biodegradable or organic washing products.

3.2 FEES

Awardee fee: Selected Food and Drink trucks/stands will be required to pay the Agency a fee to operate on the night amounting to:

Quarry Wharf Eur 200 per truck/stall

Fees are refundable only in case of cancellation of the event.

Local council permit of Eur 23.29 is to be directly paid by the applicants to the Valletta Local Council.

3.3 SET UP & DISMANTLING

1. The successful applicants must set up in the spaces as specified in the presence of the organizers and, once agreed on with the Agency, must not exceed the boundaries of these designated spaces.
2. The **setting up of equipment** must be completed on **24th June 2022 by not later than 16:00 hours**. It is not permissible to leave any parked commercial vehicles and machinery at the allocated spaces except for the food truck itself.

The equipment must be dismantled once the event has ended. This entails that by **26th June 2022 at 04:00 hours** every stall owner will have removed and cleaned any type of waste. It is the responsibility of the applicant to ensure proper clean-up procedures are implemented; no solid or liquid wastes are to be left on site.

3. Every applicant must provide his or her own equipment including canopies, fridges and draught units lighting and stands at his or her own expense. Electricity supply will be provided by the Agency for the operation of the stalls.
4. The successful applicants must provide their own bins to use for the waste generated during service. This waste is within the responsibility of the applicant and must be taken care of as needed. The applicant must provide recycling bins as well as bins for general waste.
5. Any type of waste is to be collected and disposed of by the economic operator in accordance with local environmental regulations. It is the responsibility of the selected economic operator to ensure proper clean-up procedures are implemented; no solid or liquid wastes are to be left on site or disposed of in the space.
6. A parking space can be arranged by the Agency for use of storage and this will be close by but offsite.

3.4 PERMITS AND LICENSES

1. The selected economic operator shall conform to local Health and Safety regulations, the regulations and legislation of the Maltese catering industry, any licenses and permits necessary to be eligible to sell/trade and the VAT Department as well as with the Covid 19 regulations that will be up at that time.
2. The selected economic operator shall be in possession of a valid Food Handlers Certificate.
3. Every individual serving food must wear the necessary protective clothing and use gloves and any other form of protective hygienic gear.
4. All food items for sale must conform to the local sanitary regulations set by authorities and the applicant must have all the necessary licenses and permits so as to sell the product. Such permits may be requested at any time by the Contracting Authority.
5. Only if required by the Health Department regulations in force at the time, all trucks./stalls must be equipped with screens or similar protective equipment between seller and customer in order to hinder the spread of COVID-19.
6. The selected economic operator selling alcohol must be in possession of a Licence for selling alcohol if any alcohol shall be sold by the stand/truck. All necessary legal requirements are the responsibility of the applicant. The Contracting Authority will not be liable for any action or fines incurred by the chosen applicant as a result of non-compliance with local regulations.
7. The selected economic operator shall ensure that all the staff that will be working on site are compliant with the regulations of the Health Authorities at the time in terms of their vaccination status.
8. All Maltese Laws relevant to the activity must be observed by the selected economic operator.
9. The selected economic operator(s) shall at all times respect the Mandatory standards for mitigation measures for the Covid-19 transition phase issued under the Public Health Act Chapter 465.
- If the selected economic operator(s) is caught breaking any of the above-mentioned conditions as well as local COVID-19 related conditions as published by the Health Authorities, he/she may be requested by the Contracting Authority and/or other competent local authorities to close the stall and discontinue the sales with immediate effect. The economic operator(s) will not be entitled to any compensation and shall be liable to settle any fines incurred by the competent local authorities. Any fines incurred or Court proceedings resulting from such actions shall be entirely borne by / be the responsibility of the economic operator(s). In addition, any request for reimbursement of fees shall not be entertained.
10. The selected economic operator(s) shall have all the necessary insurance policies including public liability; which covers any form of risks including damage, loss, bodily harm, death in

relation to third parties. The Contracting Authority shall not be involved in any legal dispute as result of the economic operator(s)' operations in connection with event. A copy of a valid public liability insurance policy shall be submitted to the Contracting Authority **upon contract endorsement**.

Failure to provide such documentation upon contract endorsement shall lead to the automatic forfeiting of the contract by the selected contractor and shall waive any obligation of the Valletta Cultural Agency.

11. Only if required by the Health Department regulations in force at the time, a copy of the applicant's and staff's COVID-19 vaccine certificates are to be presented **upon contract endorsement**.

Failure to provide such documentation upon contract endorsement shall lead to the automatic forfeiting of the contract by the selected contractor and shall waive any obligation of the Valletta Cultural Agency.


3.5 FOOD TRUCK / DRINK STALL LOCATIONS

The application shall be declared null if after any information provided is incorrect, falsified and not verified. The Contracting Authority reserves the right to instigate legal proceedings against the applicant in case of submission of false declarations and documentation.

1. INTRODUZZJONI

L-edizzjoni tal-2022 tal-Valletta Pageant of the Seas tiċċelebra t-80 anniversarju tal-Konvoj ta' Santa Marija permezz ta' tlielaq tad-dgħajjes, mužika, projezzjonijiet, prestazzjonijiet u logħob tan-nar.

Iż-żona kkonċernata hija ż-żona ta' Xatt il-Barrieri u f'din iż-żona m'hemmx bieżżejjed postijiet tal-ikel u x-xorb biex jaqdu lin-numru ta' persuni li mistennija jattendu.

L-Aġenzija Kulturali għall-Belt Valletta qed tistieden operaturi ekonomiċi prospettivi biex jissottomettu applikazzjoni biex jirregistraw l-interess tagħhom fil-provvista ta' gabbani tal-ikel u x-xorb lill-udjenza matul il-lejl skont il-kundizzjonijiet t'hawn taħt.

Dikjarazzjoni ta' čaħda ta' responsabbiltà:

Qabel il-COVID, in-numri tal-udjenza għall-avvenimenti tal-Valletta Pageant of the Seas kienu jvarjaw bejn 20,000 u 25,000 ruħ fil-Belt Valletta u aktar mifruxa madwar il-Port il-Kbir. L-avveniment se jsegwi r-regolamenti tas-saħħha fis-seħħ dak iż-żmien. F'każ ta' restrizzjonijiet fuq in-numru ta' attendanti permessi, meta taċċetta proposti għal Gabbani tal-Ikel u x-Xorb, l-Aġenzija ser tirrispetta proporzjon gabbana waħda (1) tal-ikel u x-xorb għal kull 1000 ruħ li jattendu.

14. Kull trakk/stand għandu juri b'mod ċar lista ta' prezziżżejjet għal kull oġgett għall-bejgħ f'żona prominenti fejn il-pubbliku jista' jaraha faċilment. Il-prezzijiet għandhom ikunu konformi mar-regolamenti lokali.

18. L-applikant irid jikkonforma mal-Politika Ambjentali tal-Aġenzija Kulturali għall-Belt Valletta kif elenkat hawn taħt:
 - f. L-ippakkjär għandu jitnaqqas f'ras il-ġħajn. Tużax jew tippromwovi prodotti li għandhom ippakkjär mhux meħtieġ u naqqas l-ippakkjär kollu kull meta jkun possibbi. L-ippakkjär għandu jkun magħmul minn materjali kompostabbi.


